The regular meeting of the Carbon County Commissioners was held Tuesday, January 3, 2006 at the Carbon County Courthouse, Rawlins, WY. Attending the meeting were Chairman Artlin Zeiger; Commissioner Terry Weickum; County Clerk, Linda Ann Smith; Chief Deputy Clerk, Diana Obe; Deputy Clerk; Gwynn Rothenberger. Commissioner Lee Meacham joined the meeting at 9:35 a.m.

Chairman Artlin Zeiger called the meeting to order at 9:00 a.m.

OATH OF OFFICE - COUNTY ASSESSOR

Clerk Smith administered the Oath of Office for elected officials and a separate Oath of Office for County Assessor to Sheryl Snider. Ms. Snider then executed her Oaths of Office dated January 3, 2006. Ms. Snider will fill the unexpired term of Darrell Stubbs, who retired December 31, 2005.

Clerk Smith acknowledged Sandy Rose and Kathy Makinen for 10 years of service, and Michelle Becotte and Liz Greenwood for five years of service with the County Clerk's Office.

Minutes

Commissioner Weickum moved to approve the minutes of the December 20, 2005 regular meeting and the December 28, 2005 special meeting of the Board of Carbon County Commissioners as presented. Chairman Zeiger seconded and the motion carried unanimously.

Bonds

Commissioner Weickum moved to approve bonds for Allison Jill Couch, Treasurer for Carbon County School District No. 1 in the amount of \$50,000.00, and Janet R.B. Herold, Clerk/Treasurer for the Town of Baggs in the amount of \$50,000.00. Chairman Zeiger seconded and the motion carried unanimously.

ELECTED OFFICIALS

Assessor

County Assessor, Sheryl Snider, presented several rebates for the Chairman's signature.

Treasurer

County Treasurer Cindy Baldwin presented Applications for Deposit of Public Funds from The Bank of Commerce and The Rawlins National Bank. Both are requesting to remain depositories for the year of 2006. Ms. Baldwin also presented an Application for Deposit of Public Funds from the Rawlins National Bank regarding depositing funds from the Carbon County Detention Facility Joint Powers Board (JPB).

Commissioner Weickum moved to accept The Bank of Commerce and The Rawlins National Bank as depositories for Carbon County for the year 2006 and to accept The Rawlins National Bank as a depository for 2006 for the Carbon County Detention Facility Joint Powers Board. Commissioner Weickum seconded and the motion carried unanimously.

The Detention Facility depository will be sent to the Carbon County Detention Facility JPB for approval.

Disclosure Statements

Ms. Baldwin presented disclosure statements for herself and Joy Hannum, Chief Deputy Treasurer. These statements disclose all interest these individuals have in banking institutions that Carbon County has money invested.

Disclosure statements were also presented from Linda Ann Smith, County Clerk; Diana Obe, Chief Deputy Clerk; and County Commissioners Artlin Zeiger, Terry Weickum, and Lee Meacham. All statements are on file in the County Clerk's Office.

EMERGENCY MANAGEMENT

Greg Zabel reported the partial window replacement is complete at the Armory. Mr. Zabel also reported on scheduling of the Armory and the schedule for the Carbon County Pipeline Association.

HOMELAND SECURITY

Pam Farster reported on various homeland security grant balances and purchases. Ms. Farster again discussed a possible grant application in the amount of \$150,000.00 with a 25% match from the county to prepare a mitigation plan. The Board directed Ms.

Farster to prepare the grant application and return it for its final approval.

SENIOR SERVICES

Terri Archer reported that the oven has been installed in the Elk Mountain Senior Center. She had no other report.

EXECUTIVE SESSION

Commissioner Meacham moved to go into executive session at 10:03 a.m. with Linda Smith and Diana Obe to discuss personnel. Commissioner Weickum seconded and the motion carried unanimously.

Commissioner Weickum moved to come out of executive session at 10:40 a.m. Commissioner Meacham seconded and the motion carried unanimously.

Chairman Zeiger stated that no action was taken during the executive session.

DOWNTOWN DEVELOPMENT AUTHORITY

DeShann Schinkel reported that Rawlins has been selected as a finalist for the Wyoming Main Street Program. Ms. Schinkel is requesting the Board's support for the program for the next three years. Her request for 2006 is \$7,600.00.

The Board agreed to provide a letter of support for the program and asked her to return during its normal budget cycle to request funding. The board also stated it could not provide a promise of support for more than one year at a time.

Commissioner Weickum questioned the DDA's involvement with the Barn Again project and requested Ms. Schinkel to provide an accounting of the funding given by the county for the project. Ms. Shinkle stated the funding was run through a separate entity but that she would try to access the information for the Board. Clerk Smith also offered to research the funding to determine the amount given and who it was paid to.

ROAD & BRIDGE

Bill Nation reported on budget issues stating that due to gas and diesel price increases, he anticipates going over those line items as well as utilities. Clerk Smith advised the Commissioners that several departments will go over line items but not the bottom line budget, and that in May, she will present budget amendments if necessary.

Area Work

Mr. Nation reported that gravel continues to be hauled to the 20-mile road. He anticipates receiving a State Land and Investment Board grant on January 19, 2006, to assist with dust abatement. Gravel will soon be hauled to the Fair Grounds to complete the north side of the parking area.

New Road

Mr. Nation reported he has been contacted by the City of Rawlins asking for input and a possible cooperative effort to build a new industrial road to transport pipe from the Union Pacific Railroad (UPRR) yard to the Glenn Addition or Higley Boulevard at a storage location. Mr. Nation reported he met with Jim Wells and Duane Stolns regarding the location of the road and various other issues.

Mr. Nation offered that his department could supply the manpower and equipment to build the road with the Board's approval. He anticipates this to be of similar length and terrain as the county-built road to the Rochelle Ranch Golf Course and suggests the landowner, UPRR, would supply a 100' right of way and the City of Rawlins would be

responsible for any utility locates. The Board stated its concerns for the Glenn Addition option as there is a housing community located there that trucks would go through. Discussions are ongoing.

The Board authorized Mr. Nation to negotiate with the City and UPRR regarding easements and payment agreements for the road.

County Vehicle

Mr. Nation stated that the county van has been totaled as a result of a recent accident. The van is currently being stored at the Road & Bridge Shop. Mr. Nation has visited with a local dealer regarding a possible trade of the vehicle for a used 2005 Chevrolet Van and presented a cost estimate including a trade in allowance. The Board stated it will consider the offer and discuss this with Karen Larsen of the GIS Department as she is the primary user of this vehicle.

BOYS AND GIRLS CLUB

Merri Addison of the Boys and Girls Club presented a revised funding request. She previously requested funding for herself and other staff to attend various trainings in various states and the Board requested she prioritize these and return with a revised request. The current request totals \$11,613.00 for two trainings seminars and funding for a high school program coordinator.

Commissioner Meacham moved to authorize \$813.00 for the Boys and Girls Club of Carbon County for one training seminar. Commissioner Weickum seconded and the motion carried unanimously.

The Board advised Ms. Addison to revisit them during their normal budget cycle to request funding from its next fiscal year's budget.

GIS / GPS

Karen Larsen stated she will determine if the vehicle found by Mr. Nation will suit her needs and report back.

MUSEUM

Denise Patton, Museum Director, Charles Stirum, and members of the Museum Board discussed their primary choice of a site for a new county museum. The group presented a proposed resolution making the decision official that the Board pursue the purchase of land at Merrill Hill in Rawlins for the new building.

Commissioner Meacham moved to adopt Resolution No. 2006-01, A Resolution Authorizing Submission of an Application for the Acquisition of Land from the Bureau of Land Management Under the Recreation and Public Purposes Act for the Board of Carbon County Commissioners, for the Construction of the Carbon County Museum at the Merrill Hill site. Commissioner Weickum seconded and the motion carried unanimously.

RESOLUTION NO. 2006-01

RECESS

Chairman Zeiger recessed for lunch at 12:02 p.m. and reconvened at 2:00 p.m.

PLANNING & DEVELOPMENT

Will Speer and Kristy Rowan presented Planning & Zoning Case Files #05-23 and #05-24 and stated the Planning Commission has recommended both cases be scheduled for public hearing.

Commissioner Meacham moved to accept Planning & Zoning Case File #05-23, Richard and Margaret Karstoft, a request for a Zone Change from Residential (RD-10) to Rural Residential Agriculture (RRA-10), on approximately 10 acres and set for public hearing on February 7, 2006 at 2:00 p.m. at the County Courthouse, Rawlins, Wyoming. Commissioner Weickum seconded and the motion carried unanimously.

Commissioner Weickum moved to accept Planning & Zoning Case File #05-24, Michael and Diane Morris, a request for a Zone Change from Ranching, Agriculture, Mining (RAM) to Forestry Production & Seasonal Recreation (FPSR-40) on approximately 40 acres and set for public hearing on February 7, 2006 at 2:00 p.m. at the County Courthouse, Rawlins, Wyoming. Commissioner Meacham seconded and the motion carried unanimously.

Mr. Speer reported the Planning Commission held a public hearing regarding proposed amendments to the Subdivision Regulations of Carbon County concerning the minor division of lands and concerning Sections 1.18.03 and 1.18.04, and recommends the Board of Carbon County Commissioners hold a public hearing to approve these amendments.

Commissioner Meacham moved to accept the Proposed Amendments to the Subdivision Regulation of Carbon County concerning minor division of lands and set a public hearing for March 7, 2006 at 2:00 p.m. at the County Courthouse in Rawlins, Wyoming. Commissioner Weickum seconded and the motion carried unanimously.

Commissioner Weickum moved to accept the Proposed Amendments to the Subdivision Regulations of Carbon County concerning Sections 1.18.03 and 1.18.04 and set for public hearing March 7, 2006 at 2:00 p.m. at the County Courthouse in Rawlins, Wyoming. Commissioner Meacham seconded and the motion carried unanimously.

Mr. Speer stated the Planning Commission plans to proceed as much as possible

without a county planner, with the subdivision regulation changes.

Mr. Speer also reported he was re-elected by the Planning Commission as Chairman and Sonja Collamer has been elected Vice-Chairperson.

GROSS SALARY PUBLICATION

Commissioner Weickum moved to approve and publish the Publication of Gross Salaries for Carbon County Employees as of January 3, 2006. Commissioner Meacham seconded and the motion carried unanimously.

FIRE TRUCK LEASE

Clerk Smith presented amortization schedules from both Kinetic Leasing and the Bank of Commerce for the lease/purchase of two new fire trucks. Clerk Smith stated that she requested that neither company have any prepayment penalties. The Bank of Commerce proposes 4.85% for a total with interest of \$329,689.49 and Kinetic Leasing proposes 4.6% for a total with interest of \$322,596.00.

Commissioner Weickum moved to approve the lease/purchase plan with Kinetic Leasing at a rate of 4.6% with nine semi-annual payments totaling \$322,596.00, for the purchase of two new fire trucks. Commissioner Meacham seconded and the motion carried unanimously.

SHERIFF

Jerry Colson discussed his utility and contract housing budget. Sheriff Colson stated that \$60,000.00 was budgeted for utilities and to date, almost \$43,000.00 has been spent. Sheriff Colson estimates that utilities will overrun his fiscal budget by approximately \$50,000.00.

Sheriff Colson also stated he budgeted \$50,000.00 for contract housing and his budget currently shows a deficit of approximately \$19,000.00 and he expects much more by the end of the fiscal year.

Clerk Smith advised to keep using the proper line items to pay these invoices and if needed, at the end of the fiscal year, a budget amendment could be made.

CARBON COUNTY FAIR BOARD

Anna Helm of the Carbon County Fair Board requested funding to purchase a used four -wheeler and snowplow from Carbon County Weed and Pest in the amount of \$1,293.85. Ms. Helm stated this would be used primarily to plow the Carbon Building, Jeffrey Center, and Courthouse sidewalks.

The Board agreed to allocate funding for in the total amount of \$1,293.85 and advised Ms. Helm to provide the Clerk's Office with an invoice from Weed and Pest.

Ms. Helm reported the Fair Board has contacted Saratoga architect, Dave Johnson, to prepare plans to build the shower house at the Fair Grounds. The Boards goal is to have the structure complete by the 2006 Fair.

EXECUTIVE SESSION

Commissioner Meacham moved to go into executive session with Linda Smith, Jerry Colson, and Tom Thompson at 3:30 p.m. to discuss litigation. Commissioner Weickum seconded and the motion carried unanimously.

Commissioner Meacham moved to come out of executive session at 4:10 p.m.

Commissioner Weickum seconded and the motion carried unanimously.

Chairman Zeiger stated that no action was taken during the executive session.

ADJOURNMENT

There being no further business, Chairman Zeiger adjourned the meeting at 4:11 p.m.
