#### **CLERK**

#### **Minutes**

Clerk Rothenberger presented the minutes from the March 20, 2007 meeting and advised she amended Page 7, General Discussion to state that the Carbon County Visitors Council awarded the Rawlins Museum a \$3,800.00 grant, not the Wyoming Business Council.

Commissioner Paxton moved to approve the minutes from the March 20, 2007 regular meeting of the Board of Carbon County Commissioners as presented. Commissioner Weickum seconded and the motion carried unanimously.

## Wyoming's Resource Conservation and Development Program (RC&D)

Clerk Rothenberger advised Denise Patton volunteered to serve as Carbon County Representative on the Wyoming's Resource Conservation and Development (RC&D) Board. She stated the dues are \$100.00 per year plus travel fees for out of town meetings.

Commissioner Weickum moved to approve payment of dues in the amount \$100.00 and to appoint Denise Patton as Carbon County's Representative on the Wyoming's Resource Conservation and Development Program (RC&D) Board, and to reimburse Ms. Patton travel fees to attend out of town meetings. Commissioner Paxton seconded and the motion carried unanimously.

## Little Snake River Rural Health Care District

Clerk Rothenberger presented a resolution establishing the Little Snake River Rural Health Care District setting its boundaries, and confirming the election of the initial board of directors. She stated that Attorney Cindy DeLancey has reviewed the resolution and recommended approval. She advised this resolution is required by the Department of Revenue.

Linda Fleming stated County Assessor, Sheryl Snyder, advised her Little Snake River Rural Health Care District was not on the tax levy list she received from the Department of Revenue. She stated she met with the Department of Revenue and Department of Audit and they advised her Little Snake River Rural Health Care District would need this resolution as their forming document. Ms. Fleming advised the district will not be eligible to levy a tax this year as the documentation was not provided by the due date. She advised this could affect the doctor situation as the current doctor is retiring.

Commissioner Paxton moved to approve Resolution No. 2007-11, A Resolution Establishing the Little Snake River Rural Health Care District Setting its Boundaries, and Confirming the Election of the Initial Board of Directors. Commissioner Weickum seconded and the motion carried unanimously.

## **RESOLUTION NO. 2007-11**

A RESOLUTION ESTABLISHING THE LITTLE SNAKE RIVER RURAL HEALTH CARE DISTRICT SETTING ITS BOUNDARIES, AND CONFIRMING THE ELECTION OF THE INITIAL BOARD OF DIRECTORS WHEREAS, pursuant to Wyoming Statute Section 35-2-701, a Petition for establishment of a Little Snake River Rural Health Care District signed by twenty-five percent (25%) or more of the property owners owning at least twenty-five (25%) or more of assessed valuation of property within the area proposed as the district was presented to the Board of County Commissioners of Carbon County, Wyoming, a public hearing was held within 90 days after the presentation of the Petition to the Board of County Commissioners to describe the proposed district and its boundaries at which time any person could appear at the hearing and be heard concerning the creation of the district, thereafter an election was held within sixty (60) days upon the question of the organization and establishment of the district.

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING:

- 1.) THAT the actions taken by the Board on the petition of property owners, which are not inconsistent with the provision of Wyoming Statute Section 35-2-701 and the Special District Elections Act of 1994 are ratified, accepted and confirmed.
- 2.) THAT an election was held on the 1<sup>st</sup> of December, 2006 to organize the district, wherein the electorate in the proposed district voted to establish the district and elected its first Board of Directors, and the Little Snake River Rural Health Care District is hereby established, and it's a body corporate designated by the name Little Snake River Rural Health Care District.
- 3.) THAT the boundaries of the district are as follows:

That portion of Carbon County, Wyoming, bounded by the following described line:

"Beginning at the southwest corner of said Carbon County, the intersection of the West line of Carbon County, with the North line of the State of Colorado;

Thence North along the West line of Carbon County to the Northwest Corner of Township 19, Range 93 West;

Thence East along the County line to the Northeast corner of Township 19 North, Range 91 West;

Thence South along the East Line of Township 19 and 18 North, Range 91 West, to the Southeast corner of Township 18 North, Range 91 West;

Thence East along the North line of Township 17 North, Range 90 and 89 West, to the northeast corner of Township 17 North, Range 89 West;

Thence South along the East line of Township 17 North, Range 89 West, to the Southeast corner of Township 17 North, Range 89 West;

Thence East along the North line of Township 16 North, Ranges 88 and 87 West to the Northeast corner of Township 16 North, Range 87 West;

Thence South along the East line of Townships 16, 15, 14, 13 and 12 North, Range 87 West to the intersection with the South line of Carbon county, and North line of the State of Colorado;

Thence West along the South line of Carbon County to the point of beginning.

**4.)** THAT the following persons were nominated and elected to serve as trustees on the initial Board of the District; as certified by the County Clerk of Carbon County:

Clerk Rothenberger advised she would immediately forward copies of the Resolution to the Little Snake River Rural Health Care District, the Wyoming Department of Revenue, and the County Assessor's Office.

#### **Bonds**

Commissioner Weickum moved to approve a bond for Lezlee Musgrave, Clerk/Treasurer of the Town of Sinclair in the amount of \$8,000.00. Commissioner Paxton seconded and the motion carried unanimously.

## **Local Government Liability Pool (LGLP) Renewal**

Clerk Rothenberger presented the Local Government Liability Pool (LGLP) Renewal Membership Application and advised that previously, premiums were based on operating expenses. This year, however, premiums will be based on payroll only. She added that the current deductible per incident is \$5,000.00 and questioned if the Board would like to maintain with this amount.

The Board advised they would like an estimate of the premiums based on the various deductibles before making a decision on the deductible amount. Clerk Rothenberger advised she would contact the LGLP for this information.

## **Little Rascals Preschool Lease Agreement**

Clerk Rothenberger presented a Lease Agreement for Little Rascals Preschool to lease the premises located at 350 Whippoorwill Drive in Baggs, Wyoming. She stated the term of the lease is for one year expiring in March 2008 and in the amount of \$10.00.

Commissioner Weickum moved to approve the Lease Agreement between the Board of Commissioners of Carbon County and Little Rascals Preschool in the amount of \$10.00 for one year expiring March 31, 2008. Commissioner Paxton seconded and the motion carried unanimously.

## **Addendum to Agreement**

Clerk Rothenberger presented an Addendum to Agreement with the Wyoming Retirement System defining a regular part-time employee.

Commissioner Weickum moved to approve the Addendum to Agreement with the Wyoming Retirement System defining a regular part-time employee who will be covered as an individual who works at least 30 hours per week. Commissioner Paxton seconded and the motion carried unanimously.

## **Platte Valley Community Center Joint Powers Board**

Clerk Rothenberger advised Judy Welton was reappointed last year to the Platte Valley Community Center Joint Powers Board but that her term should not have expired until June 2007. She asked how the Board would like to correct this term expiration. The Board advised Clerk Rothenberger to advertise for this board position and they would appoint an individual for the corrected three-year term to expire June 2010.

#### **Relay for Life**

Clerk Rothenberger advised the American Cancer Society requested to hold its annual Relay for Life event on the Courthouse lawn July 27, 2007. She advised they would obtain liability insurance for the event and that the group would be responsible for cleaning up when this event is over. The Board authorized the event to be held on the Courthouse lawn with the stated conditions.

#### Saratoga Town Hall

Clerk Rothenberger stated she received the utility bills for the Saratoga Town Hall from Sue Bartlett and the Board has been provided a copy of the bills. After a brief discussion, Attorney Cindy DeLancey advised she would draft a letter to the Mayor and Town Council of Saratoga regarding the possible purchase of this building, if it should become available.

## **Building Committee**

Clerk Rothenberger advised the appointed Building Committee would meet this Friday, April 6, 2007 at 10:00 a.m.

## **Homeland Security Grants**

Clerk Rothenberger distributed the Homeland Security Grants Update prepared by Pam Farster.

## **Impact Funding**

Clerk Rothenberger advised she expects the \$5.8 million impact funding from the State Lands and Investment Board to be divided evenly between the eight impacted counties. She added that she expects to receive the application and other applicable forms next week and would forward them to each municipality immediately for approval.

### **County Vehicles**

Clerk Rothenberger advised that the Board budgeted funds to purchase Commissioners and Custodian vehicles. She asked if the board would like her to obtain bids for these vehicles. The Board advised they would discuss this issue and get back to her.

Clerk Rothenberger stated the Courthouse could use a four-wheeler with a plow to remove the snow from the north parking lot and sidewalks periodically throughout the day. There was discussion and the Board advised her to make this request in her budget request next fiscal year.

#### ELECTED OFFICIALS AND DEPARTMENT HEADS

#### **Assessor**

County Assessor Sheryl Snyder presented several abates and rebates for signature.

#### **Treasurer**

County Treasurer Cindy Baldwin advised property taxes will be due in May. She advised the capital facilities tax ended April 1, 2007. She stated she plans to invest more money, in addition to the \$4 million currently invested. Treasurer Baldwin advised the county usually averages \$40,000.00 in interest from investments, however, there is over \$100,000.00 in interest this year already.

## Road & Bridge

Bill Nation presented the Road & Bridge Report dated April 3, 2007. He reported that things are starting to get back on track after the big spring snowstorm last week. He stated they are continuing spring blading throughout the county. The 701 project is back in progress with a new aggressive plan. He advised they will start laying magnesium chloride on County Road 608 tomorrow, and this will use up the remaining funds from his CMAQ grant. The 353 gravel project will also start tomorrow, and this will use the remaining BLM parking lot/gravel mix and cover one mile, which is heavily used.

Mr. Nation advised WYDOT toured the north part of the county with him and has offered Carbon County the use of Recycled Asphalt Product (RAP) for dust abatement on County Roads #99, #100, #499.

## **Authorizations**

Mr. Nation requested and received authorization to purchase culverts in the amount of \$15,000.00, and magnesium chloride from Roscoe Steel in the amount of \$16,611.11.

Mr. Nation discussed the Coalbed Methane Coalition and stated he would like Carbon County to remain active with the Coalition. He asked each Commissioner to let him know if they would like to attend a meeting and offered to go with them.

### **Local Government Liability Pool (LGLP)**

Clerk Rothenberger stated she did talk to Monty Lauer at LGLP and he advised he would need the Renewal Membership Application signed and returned to him before he could provide the premiums for the various deductibles. Chairman Zeiger executed the Local Government Liability Pool Renewal Membership Application.

#### **RECESS**

Chairman Zeiger called a recess at 10:05 a.m. and reconvened at 10:16 a.m.

#### GIS / RURAL ADDRESSING

Karen Larsen advised she has mailed 827 letters with addresses and has received mostly positive responses. She stated she lacks 140 addresses. Ms. Larsen explained the addressing process and advised she will provide Union Telephone with the locations.

#### **ARMORY BUILDING**

Greg Zabel advised the armory sheltered 161 people during the snowstorm last week. He distributed a list of Armory users and provided an update of each.

Mr. Zabel and Loretta Weems explained the Self Help and Resource Exchange (SHARE) Program. Ms. Weems advised the program basically provides food packages once a month to anyone wishing to participate. The base packages are \$25.00 each and additional food can be purchased for a nominal fee. Ms. Weems asked for authorization to use the Armory each third Saturday monthly to distribute these packages. She further explained that the program has been running out of the Head Start building, however they do not operate during the summer months making access to the building difficult. Mr. Zabel stated he has no objection to the use of the Armory for the program. Commissioner Weickum advised he would like more information about this organization, including who profits from it.

Clerk Rothenberger offered to contact the SHARE representative in Cheyenne and obtain more information.

Commissioner Paxton moved to authorize the SHARE program to use the Armory for the month of April 2007. Commissioner Weickum seconded and the motion carried unanimously.

The Board stated that once it receives more information, they will consider authorizing long-term use of the Armory for the program.

#### **CORONER BUILDING REMODEL**

County Coroner Paul Zamora advised he received two sealed bids for remodel of the Courthouse garage for use as the County morgue. Mr. Zamora opened a bid from Brown & Sons in the amount of \$78,200.00 not including an autopsy sink. Coroner Zamora advised he can purchase the autopsy sink at a discounted price directly from Mopec in the amount of \$11,418.75.

Mr. Zamora opened a second bid from D & P Construction in the amount of \$121,000.00 plus a separate bid from S & J in the amount of \$8,775.00 for concrete.

He advised he must also purchase a \$2,000.00 specialized table, but that this would be paid for from Homeland Security grant funds. Coroner Zamora asked to review the bids and return later today with a recommendation.

#### **BOARD INTERVIEWS**

Mark Taylor, Joe Hollingshead, and Charles Reed were interviewed for consideration of appointment to the Predatory Animal Control Board.

Commissioner Paxton moved to appoint Mark Taylor to the Predatory Animal Control Board for a term of two years expiring December 2008. Commissioner Weickum seconded and the motion carried unanimously.

### **CORONER BUILDING REMODEL**

Coroner Zamora returned and clarified that both bids include concrete work. The concrete bid included with D & P Construction's bid was separate and D & P's bid did include concrete work from another contractor.

Commissioner Paxton moved to accept the low bid from Brown & Sons in the amount of \$78,200.00 to remodel the building for the Coroner's use. Commissioner Weickum seconded and the motion carried unanimously.

## **VEHICLE BIDS**

Sheriff Jerry Colson opened three sealed bids for a new vehicle. Dallin Motors bid \$24,325.00 for a 2007 Dodge pickup. #### **TRAINING**

Glenn Biggs provided an update on emergency detentions and discussed mental illness. Mr. Biggs advised the National Commission on Correction of Health Care is holding a seminar in July in Las Vegas regarding mental health care. This would provide him with  $14\frac{1}{2}$  credit hours, at a cost of approximately \$1,000.00. He added there is a similar seminar in October in Nashville providing 30 credit hours at a cost of approximately \$1,800.00. Mr. Biggs asked for approval to attend one of these seminars.

The Board advised Mr. Biggs to decide which seminar he would like to attend and coordinate it with Clerk Rothenberger. The Board advised Clerk Rothenberger to budget Mr. Biggs for training, as he is required to have approximately 40 hours of training every two years.
