

**MINUTES OF THE BOARD OF CARBON COUNTY COMMISSIONERS**  
**BUDGET WORKSHOP**  
**Thursday, June 28, 2007 & Friday, June 29, 2007**  
**County Courthouse, Rawlins, Wyoming**

A budget workshop of the Board of Carbon County Commissioners was held Thursday, June 28, 2007 and Friday, June 29, 2007 at the County Courthouse, Rawlins, Wyoming. Attending the meeting were Commissioners Artlin Zeiger, Terry Weickum and Jerry Paxton; County Clerk, Gwynn Rothenberger; County Treasurer, Cindy Baldwin.

Chairman Zeiger called the meeting to order at 9:00 a.m., Thursday, June 28, 2007.

**PROPOSED BUDGET REVIEW**

The Proposed Budget for Carbon County, Wyoming, for Fiscal Year ending June 30, 2008 was reviewed and discussed.

**RECESS**

Chairman Zeiger recessed for lunch at 12:00 p.m. and reconvened at 1:30 p.m.

There was further discussion and review of the Proposed 2007-2008 Budget.

**PLANNING & ZONING COMMISSION**

The Board asked County Attorney, Cindy DeLancey, to determine the process for separation of the Planning & Zoning Commission into two separate boards. Attorney DeLancey agreed and stated she will report to them once she researches the issue.

**RECESS**

Chairman Zeiger recessed for the day at 4:52 p.m. and declared the meeting will reconvene at 9:00 a.m., Friday, June 29, 2007.

**RECONVENE**

The meeting of the Board of Carbon County Commissioners reconvened at 9:00 a.m. Friday, June 29, 2007 at the County Courthouse in Rawlins, Wyoming. Attending the meeting were Chairman Artlin Zeiger; Commissioner Jerry Paxton; County Clerk Gwynn Rothenberger, and County Treasurer, Cindy Baldwin. Commissioner Terry Weickum joined the meeting at 9:20 a.m.

**PROPOSED BUDGET REVIEW**

The Proposed Budget for Carbon County, Wyoming, for Fiscal Year ending June 30, 2008 was reviewed and discussed.

**FIREWORKS PERMITS**

Clerk Rothenberger presented a fireworks display permit request from the Old Baldy Club and added that County Fire Warden Dwight France has approved the request.

Commissioner Paxton moved to approve a fireworks display permit Old Baldy Club for July 4, 2007. Commissioner Weickum seconded and the motion carried unanimously.

Clerk Rothenberger discussed a call received from a member of the Seminole Boat Club request to hold a fireworks display June 30, 2007 at the Seminole Boat Club. She added that Dwight France had several conditions for his approval of the display. She added that she has no written request at this time, only a verbal request.

Commissioner Paxton moved to approve a fireworks display permit for the Seminole Boat Club for the evening of June 30, 2007 only after a written request is presented to the County Clerk's Office, with the conditions that the Seminole Boat Club Board members will operate the display, the location of the display must be on the beach in front of the boat Club with fireworks being shot off over the lake, and that this permit does not give approval for anyone else to shoot off

fireworks at anytime. Commissioner Weickum seconded and the motion carried unanimously.

There being no further business, Chairman Zeiger adjourned the meeting at 12:08 p.m.
