SPECIAL MEETING

The Board of County Commissioners met this 11th day of January, A. D. 1940, at 10:00 A. M., with all commissioners present, Fred F. Hansen presiding.

Tax abatement in the amount of \$21.22 was allowed C. F. Jebens on account of erroneous assessment.

On motion by Commissioner McCarthy, seconded by Commissioner Gooldy, the following resolution awarding equipment contracts was adopted by unanimous vote of the board, in line with recommendations of Architect, F. H. Porter. The certified checks and bid bonds as submitted by the various bidders on Courthouse and Jail equipment were approved by the Board of Commissioners; the check of H. Rasmussen, Inc. was not certified but was accepted by The Board of Commissioners.

RESOLUTION AWARDING EQUIPMENT CONTRACTS

WHEREAS the County of Carbon in the State of Wyoming pursuant to an advertisement for bids for the furnishing of equipment for the Carbon County Courthouse at Rawlins, Wyoming, hereinbefore published on December 7, 14, 21, and 28, did on the fourth (4th) day of January, 1940, at two o'clock P. M., at its offices in the City of Rawlins and State of Wyoming, receive bids for the furnishing of equipment for the Carbon County Courthouse at Rawlins, Wyoming, which said bids were taken under advisement by the Board of County Commissioners, the County Attorney and the Architect.

WHEREAS the bids of the Stationers of Rawlins, Wyoming, for Items Nos. 1, 2, 4, 5, 7, 10, 13, 14, 16, 18, 19, 23, 25 and 27; the Modern Furniture Company of Rawlins, Wyoming, for Items Nos. 3, 15, 20 and 21; the Prairie Publishing Company of Casper, Wyoming, for Items Nos. 6 and 8; H. Rasmussen, Inc., of Rawlins, Wyoming, for Items Nos. 11, 12, 24 and 26; the Mills Company of Sheridan, Wyoming, for Items Nos. 9 and 17; and J. Burri Stores of Cheyenne, Wyoming, for Items Nos. 22 and 28, are the lowest and best bids submitted by any responsible bidder;

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Carbon in the State of Wyoming

That contracts for the furnishing of the abovementioned items for the Carbon County Courthouse at Rawlins, Wyoming, be awarded to the Stationers for the sum of \$1477.68, the Modern Furniture Company for the sum of \$1045.25, the Prairie Publishing Company for the sum of \$593.22, H. Rasmussen, Inc. for the sum of \$660.25, the Mills Company for the sum of \$334.07, and J. Burri Stores for the sum of \$221.45, making a total sum of \$4331.92.

PROVIDED, however, that these awards shall not be effective until each of the abovementioned firms shall have been notified in writing by the County Clerk of Carbon County of such award.
