THE BOARD OF COMMISSIONERS MET MAR. 26, 1941 AT 10:00 O'CLOCK A. M. ALL MEMBERS PRESENT, JOHN F. GOOLDY PRESIDING.

AUSTIN, CHRIS MACPHERSON AND LAWRENCE SULLIVAN BE APPOINTED APPRAISERS TO VIEW AND APPRAISE THE HANNA- ROCK RIVER HIGHWAY No. 30, AND MAKE A REPORT OF THEIR FINDINGS TO THE BOARD OF COMMISSIONERS AS SOON AS PRACTICABLE. IT WAS ALSO DECIDED THAT THE BOARD OF APPRAISERS SHOULD MEET AT 10:00 O'CLOCK A. M. MAR. 31, 1941 AT MEDICINE BOW, WYO. IN THE VIRGINIAN HOTEL, AND THAT ALL CLAIMANTS AND PROPERTY OWNERS INVOLVED, BE NOTIFIED.
