MCFADDEN FIRE STATION BID OPENING

Alternate #1 - \$9,040.00 Alternate #2 - \$10,820.00 Completion time - 150 days

The low bidder for the project was Shepard Construction of Rawlins, Wyoming.

A motion was made by Lee Meacham and seconded by Linda Fleming that Ken Richardson of Quinn/Richardson take the bids under advisement and be given authorization to negotiate with the low bidder concerning the reduction of costs. The motion carried unanimously.

<u>SETTLEMENT</u>

A motion was made by Lee Meacham and seconded by Linda Fleming to accept the settlement between State of Wyoming Department of Revenue and Santa Fe Snyder Oil for production years 1990-94 and 1991-95 for production in the Barrel Springs Unit in the amount of \$107,000. The motion carried unanimously.
