Commissioner Fleming moved to appoint John L. Anderson to the Upper Platte River Solid Waste District Board. Chairman Zeiger seconded. The motion carried unanimously.

Commissioner Fleming moved to re-appoint A. D. Jones to the Baggs Solid Waste Disposal District Board, and appoint Dennis Criswell to fill the unexpired term of Dan Gallenbeck on the Baggs Solid Waste Disposal District Board. Chairman Zeiger seconded. The motion carried unanimously.

Commissioner Fleming moved to enter into a Maintenance Agreement Contract between Ryan Electronics Incorporated and the Board of Commissioners of Carbon County in the amount of \$2,658.00 per month. The agreement shall run from from July 1, 2001 through June 30, 2002. Chairman Zeiger seconded. The motion carried unanimously.
